### GUIDELINES

- >One pet per person. Each pet will need to be accompanied by an adult.
- >Each pet owner must complete a registration for every pet, provide the animal's up-to-date rabies vaccination, and sign a hold harmless waiver.
- >Animals are only permitted to explore the Museum's back yard area and Carroll Park. Animals are not permitted inside the B&O Roundhouse, North Car Shop, Annex, Cafe.
- >Retractable leashes are not permitted.
- >Pet owners must clean up after their animal.

#### HOLD HARMLESS AGREEMENT AND RELEASE

In consideration of being permitted to hang your materials and have access to a restricted location at the Baltimore and Ohio Railroad Museum (the Property), the undersigned hereby agrees as follows: I hereby acknowledge that there are risks and dangers, both known and unknown, at the Property and I hereby assume any and all risk of personal injury (including death) and property damage which may occur during (and/or as a result of) my presence on the Property.

I hereby exempt and release the Baltimore and Ohio Railroad Museum, as well as their officers, partners, affiliates, agents, contractors, subcontractors, employees, board of directors and members from any and all claims for personal injury (including death) and/or property damage, liability and expense, including attorney's fees and court costs, caused in connection with my presence on the Property.

I agree to be solely responsible for loss or damage to my goods and any personal property while on the Property and hereby waive any claim for personal injury and/or property damage related to my presence on the Property, pursuant to this Hold Harmless Agreement.

I hereby agree to obey all safety requirements and instructions and to honor all restrictions and limitations during my personal presence on the Property.

I acknowledge all food and alcoholic beverages must be provided by and served by an approved and licensed caterer. In accordance with the law, all alcoholic beverages must be served by representatives of a licensed caterer. The Museum forbids the serving of alcohol to anyone under the age of 21 or to anyone who appears to be intoxicated. All events serving alcohol must provide the appropriate amount of food for guests. All bars must close one half hour prior to the scheduled time.
